- ☐ Typical cross sections of the proposed building(s) at a scale not smaller than 1:200
- ☐ Enlarged details of special design features

**Note:** Following the first round of review, perspective drawings may be required, including character sketches which include proposed landscaping and show adjacent buildings. For major projects, the applicant may be requested to provide a 3-D model.

For a **Liquor Licence** application, please include a clearly dimensioned layout of the premises, washrooms, patio space and/or lounge area(s), and show seating capacity and occupancy load analysis.
