BYLAW NO. 5751, 1999

A Bylaw to provide for the levying of rates and collection of taxes on real property within The Corporation of Delta for the year 1999 imposed by variable tax rates.

The Municipal Council of The Corporation of Delta, in open meeting assembled, hereby ENACTS AS FOLLOWS:-

1. This Bylaw may be cited for all purposes as "Delta Annual Rates and Tax Collection (Municipal) Bylaw No. 5751, 1999."

- 2. The following rates are hereby imposed and levied for the year 2021:
 - (a) For all lawful general purposes of the Municipality on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in Column "A" of Schedule 1 attached hereto and forming a part hereof.

(b) For purposes of Neighbourhood Road Improvements on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in Column "B" of Schedule 1 attached hereto and forming a part hereof.

- (d) For Fraser Valley Regional Library purposes on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in Column "D" of Schedule 1 attached hereto and forming a part hereof.
- (e) For purposes of the Delta Drainage Area Bylaw No. 1250, 1965, on the assessed value of land taxable for general municipal purposes, rates appearing in Column "E" of Schedule 1 attached hereto and forming a part hereof.
- (f) For purposes of the Delta Specified Area (Annacis Island Water, Sanitary Sewer and Drainage) Bylaw No. 4192, 1987, pertaining to the Annacis Island Drainage Area, on the assessed value of land taxable for general municipal purposes, rates appearing in Column "F" of Schedule 1 attached hereto and forming a part hereof.

3. The taxes for the current year as shown on the real property tax roll shall be payable on or before 12:00 midnight on the second day of July, 2021 and there shall be added to taxes remaining unpaid after the aforementioned time and date five per centum (5%) of the amount unpaid; there shall be added to taxes remaining unpaid after 12:00 midnight on the second day of September, 2021 a further five per centum (5%) of the amount unpaid.

READ A SECOND time the 4th day of May, 1999.

READ A THIRD time the 4th day of May, 1999.
