### Proposed Park Land Exchange

I am **OPPOSED** to the City of Delta proceeding with the proposed park land and school land exchange, with The Board of Education of School District No. 37 (Delta), consisting of two pieces of park land totalling 2,029 m<sup>2</sup> in exchange for one piece of school land totalling 2,029 m<sup>2</sup>, for the purpose of constructing a new second synthetic turf field at Mackie Park.

The lands subject to the exchange are located at 10900 82 Avenue (Mackie Park) and 11800 86A Avenue (Hellings Park).

## Elector Response Form

### Proposed Park Land Exchange

Pursuant to Section 86 of the *Community Charter*, the City of Delta is proposing to seek elector approval by alternative approval process.

**The question before the electors is whether they are opposed to City of Delta proceeding with the proposed park land and school land exchange, with The Board of Education of School District No. 37 (Delta), consisting of two pieces of park land totalling 2,029 m<sup>2</sup> in exchange for one piece of school land totalling 2,029 m<sup>2</sup>, for the purpose of constructing a new second synthetic turf field at Mackie Park.**

### INSTRUCTIONS

1. If you are opposed to the proposed 2,029 m<sup>2</sup> of park land and school land exchange with the Board of Education of School District No. 37 (Delta), you can sign an elector response form **if you qualify as an elector in the City of Delta.**
2. If you are NOT opposed to the proposed 2,029 m<sup>2</sup> of park land and school land exchange with the Board of Education of School District No. 37 (Delta), you do not need to do anything.
3. Forms are available at the Office of the City Clerk, City of Delta, 4500 Clarence Taylor Crescent, Delta, BC, V4K 3E2.
4. To sign an elector response form you MUST meet the qualifications as either a Resident Elector or a Non-Resident (Property) Elector of the City of Delta. If you are unsure if you qualify, please contact the Office of the City Clerk at 604-946-3220.
5. A person who obtains an Elector Response Form may make accurate copies of the form.
6. One elector of the City of Delta may sign each Elector Response Form.

All Elector Response Forms must be received by the City of Delta on or before 4:45 p.m., Monday, April 22, 2024 to be considered.

No faxed or scanned Elector Response Forms will be accepted. In other words, originally signed forms must be submitted.

#### 2.

The number of electors in the City of Delta is estimated to be 74,032. If ten percent (10% or 7,403 electors) of the estimated number of electors in the City of Delta sign an Elector Response Form in opposition to the proposed 2,029 m<sup>2</sup> of park land exchange, the City of Delta cannot proceed without receiving the assent of the electors by referendum.
