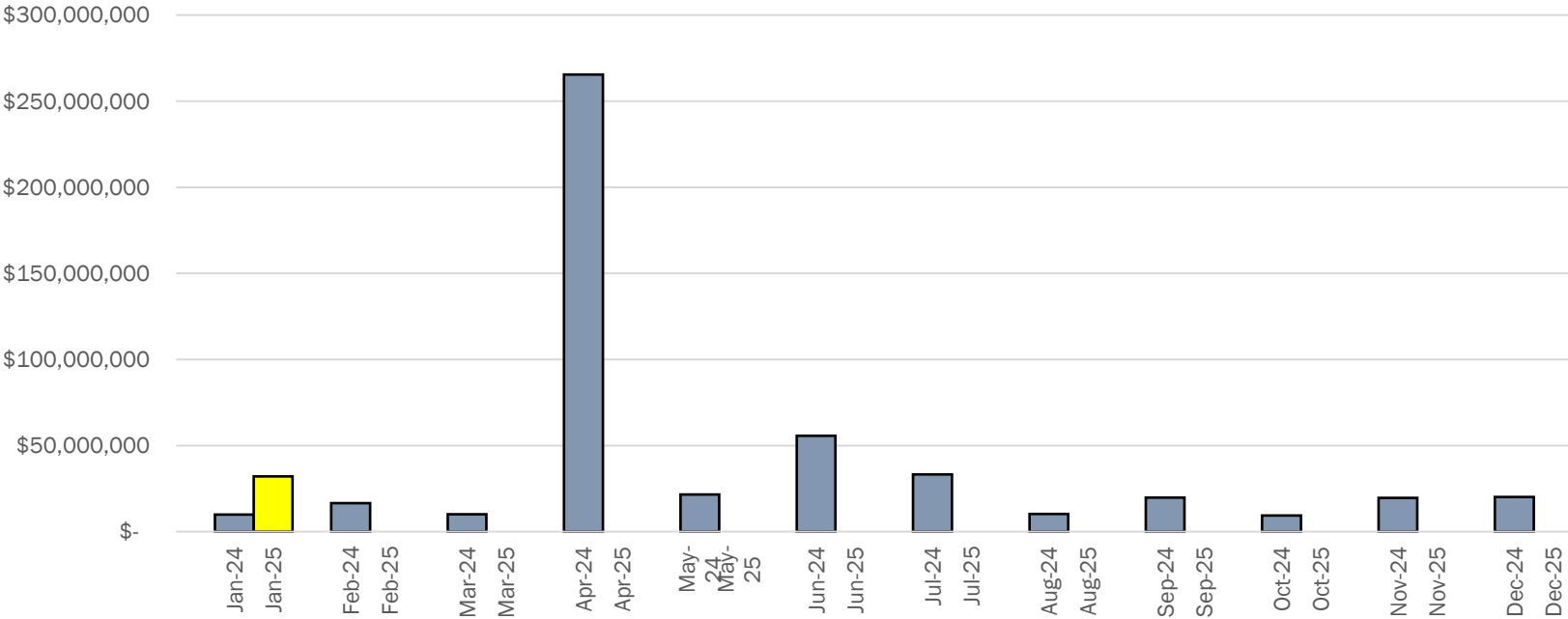
## Building Permit Applications Received Single Detached Residential January 2025



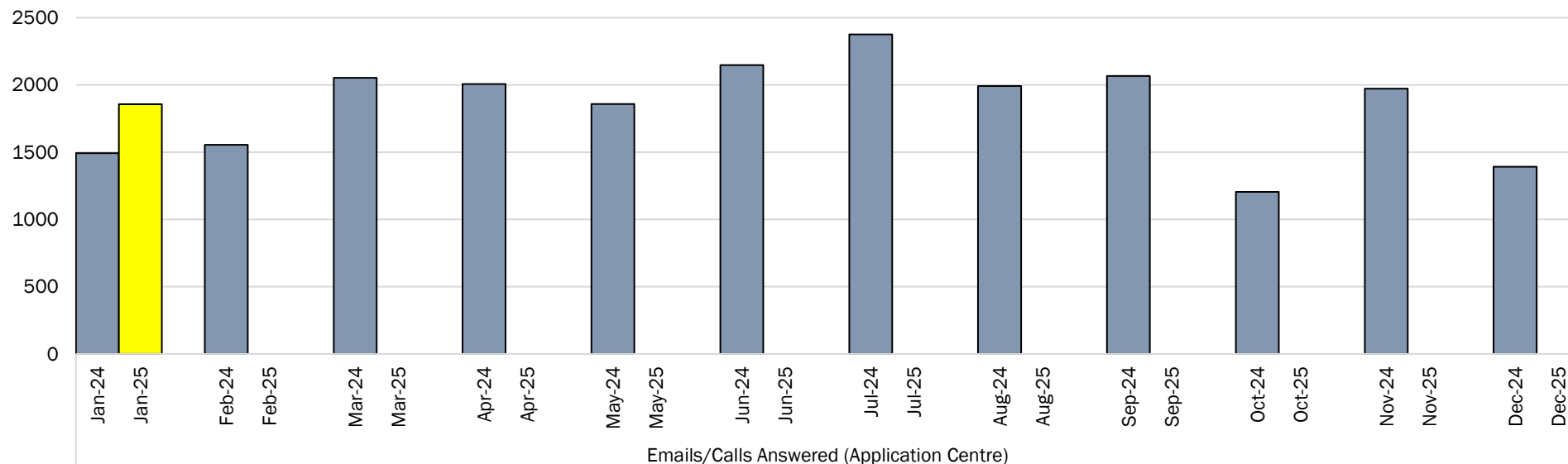

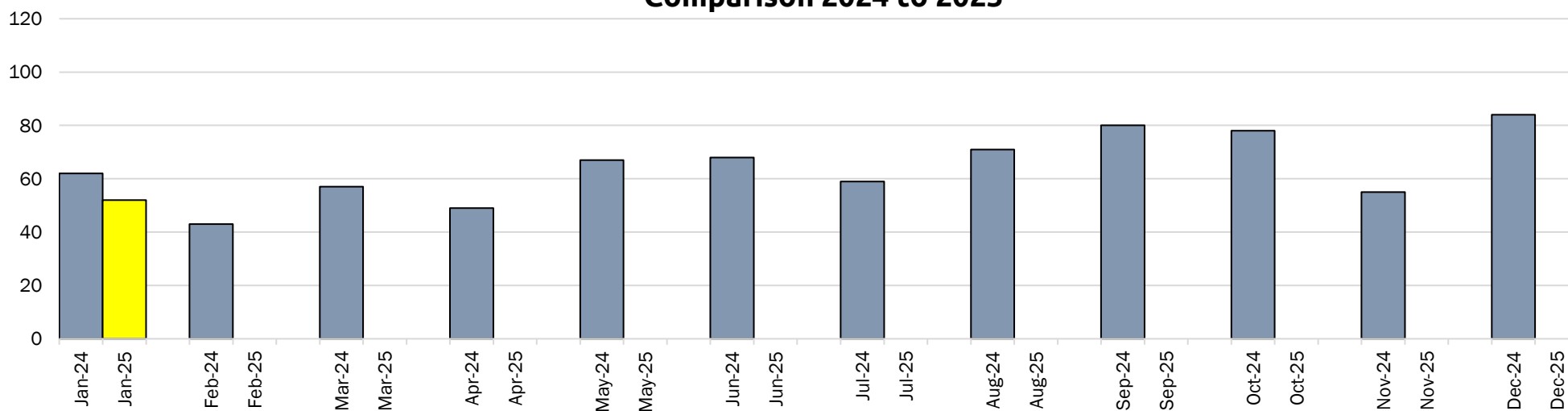

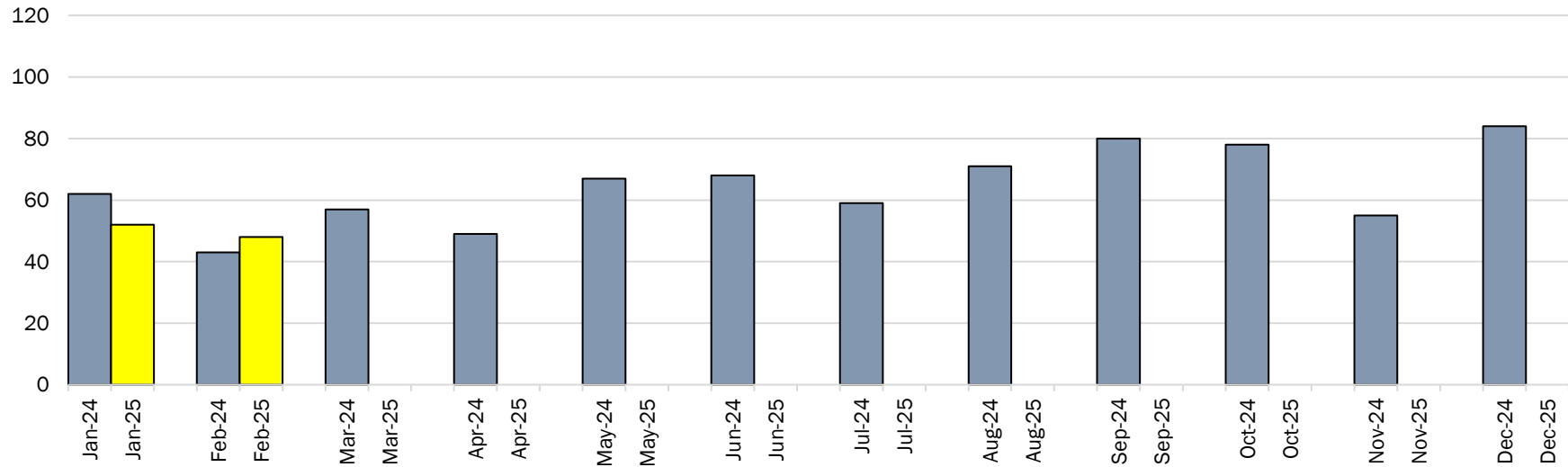

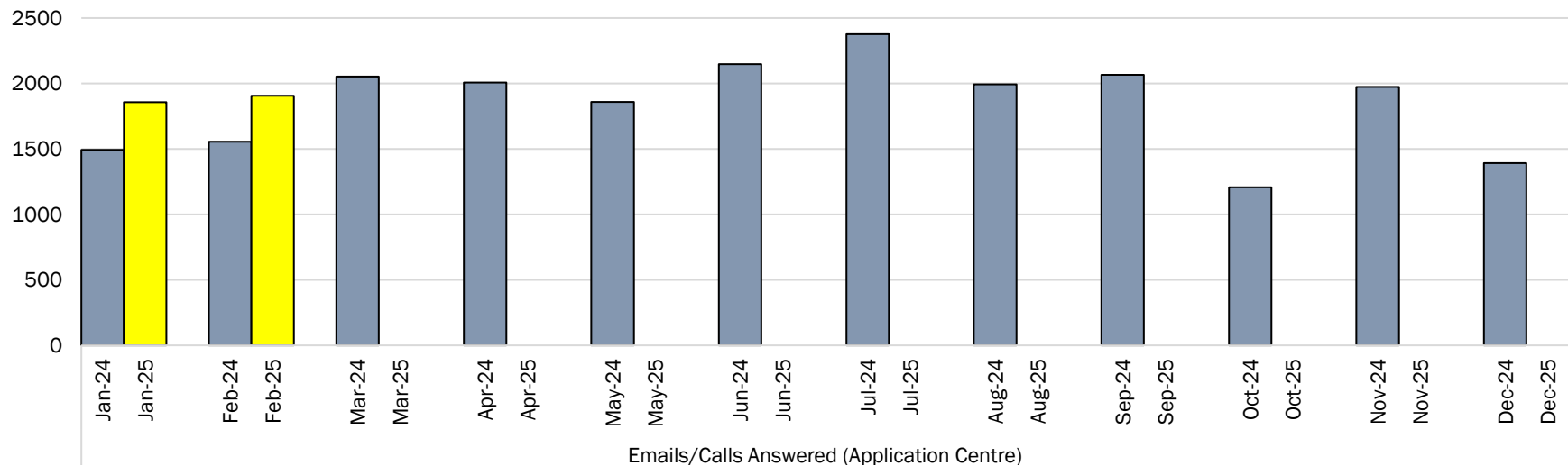

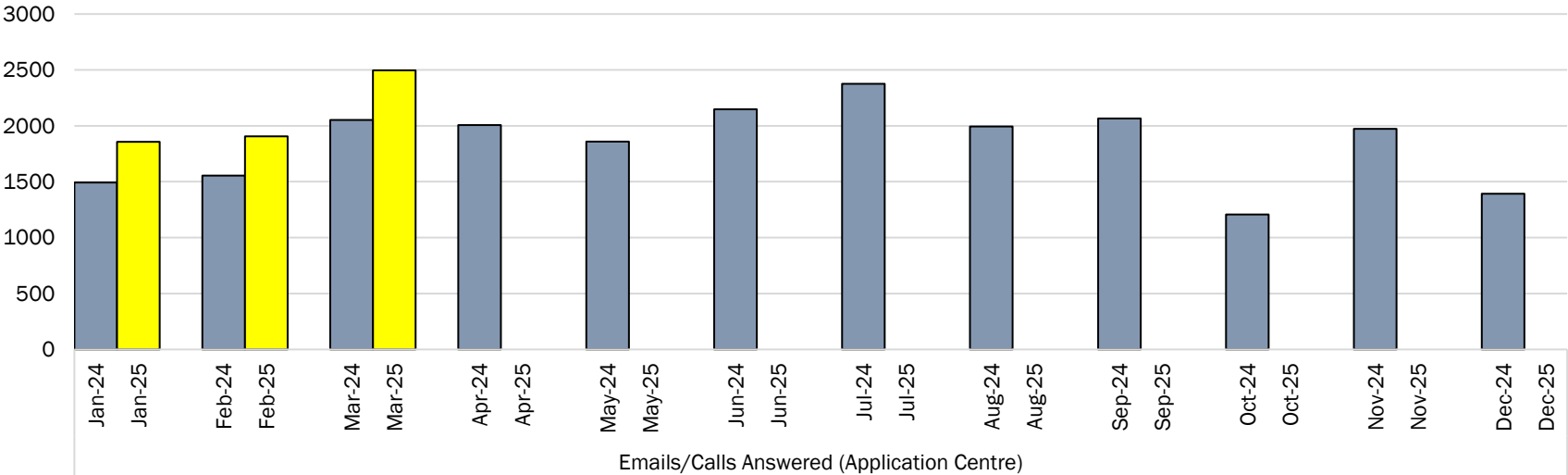


## Total Construction Value of Building Permits Issued Comparison 2024 to 2025

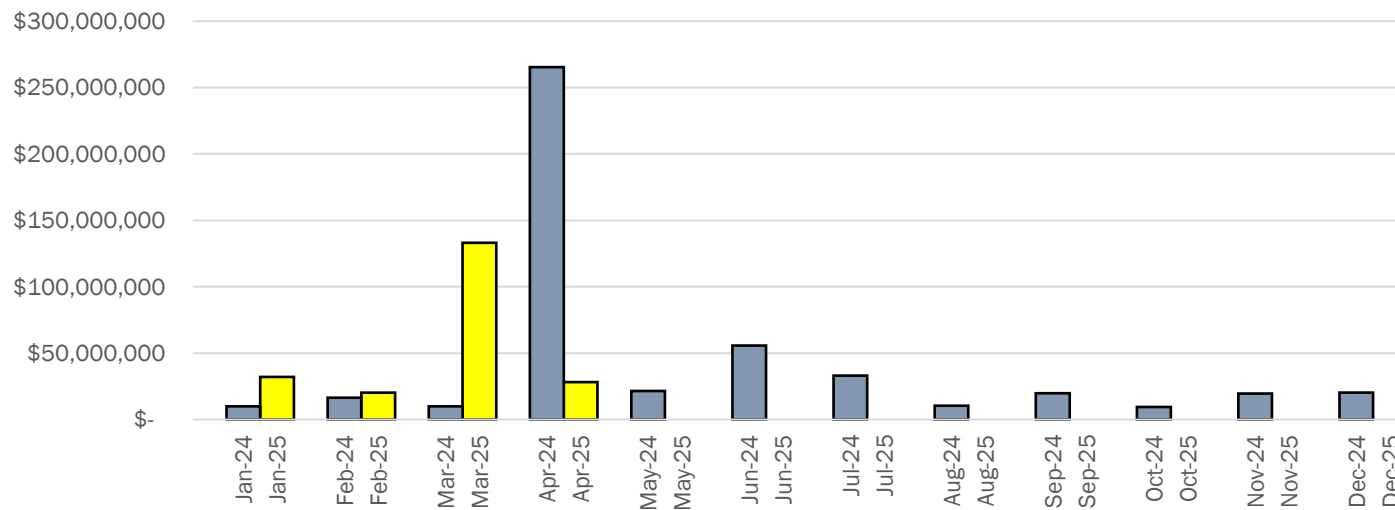
## Building Permit Applications Received Single Detached Residential April 2025

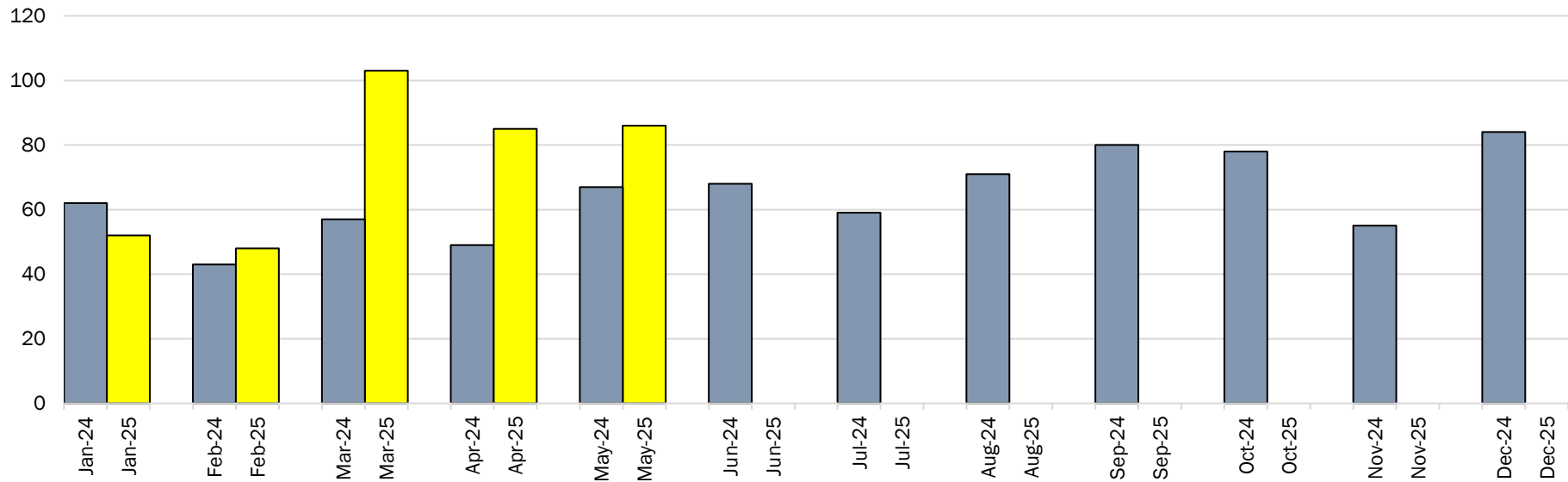
## Building Permit Applications Received Single Detached Residential May 2025



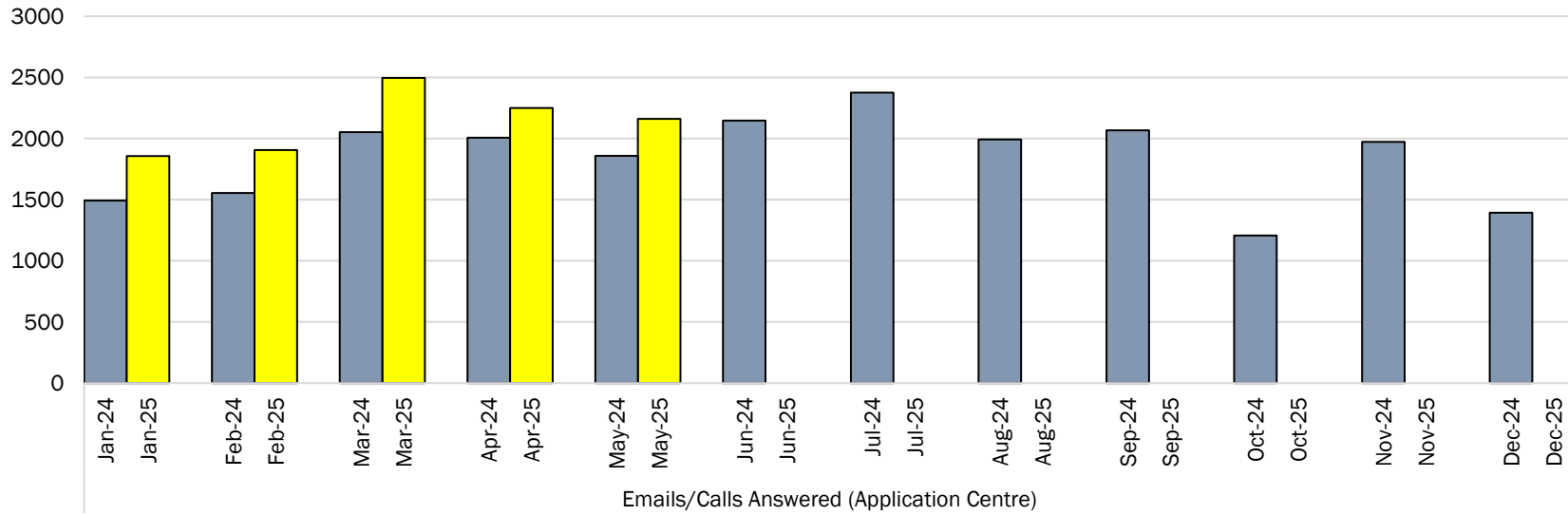

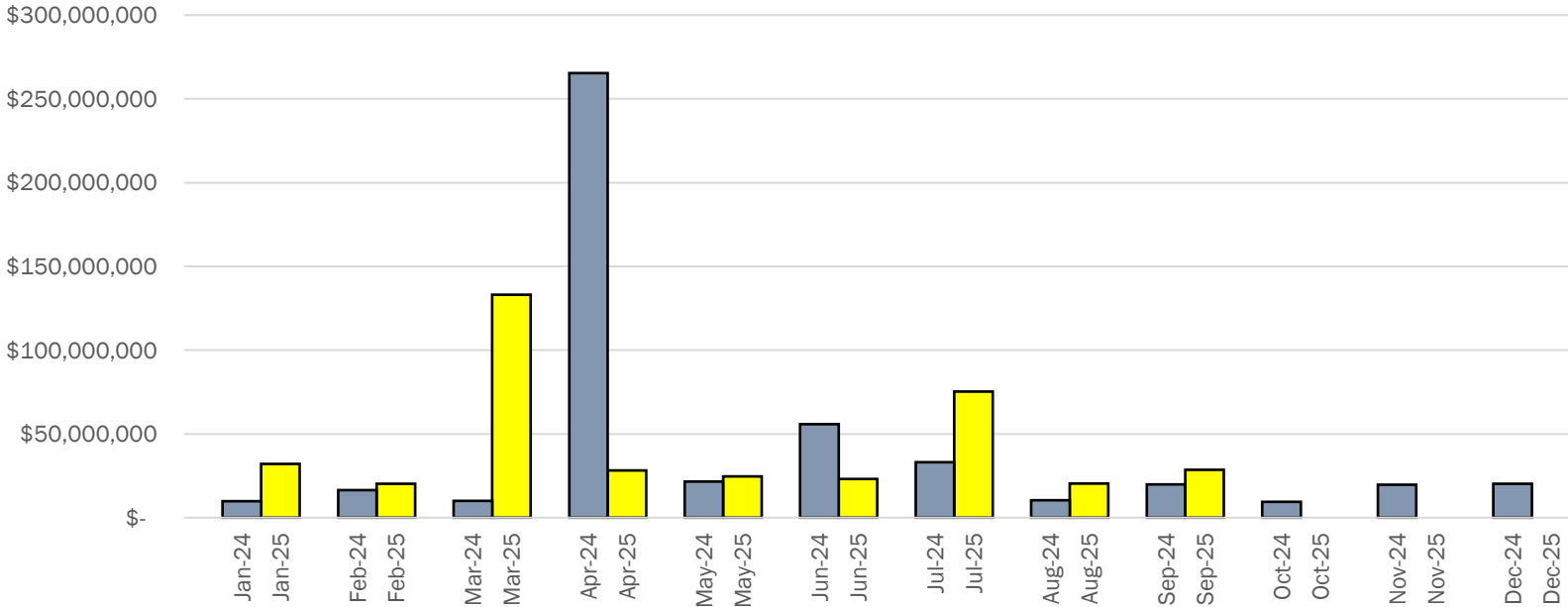
## Building Permit Applications Received Single Detached Residential September 2025

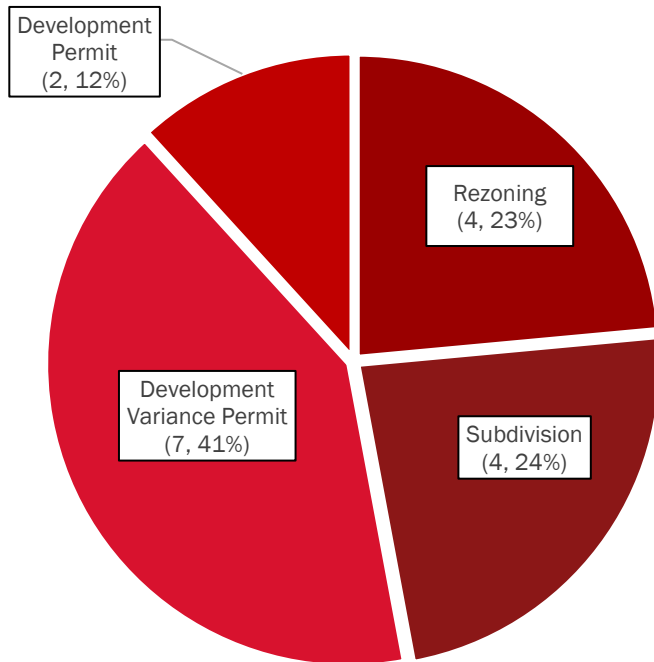

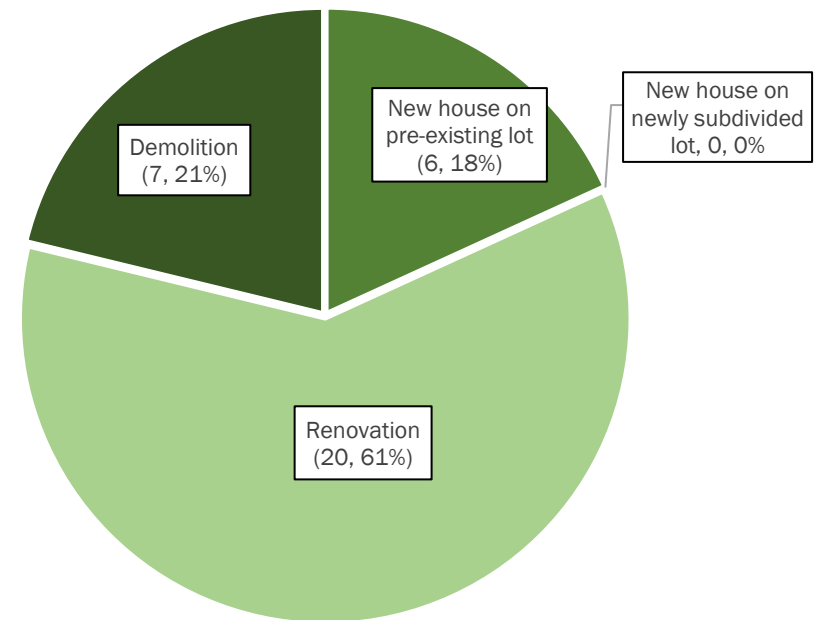

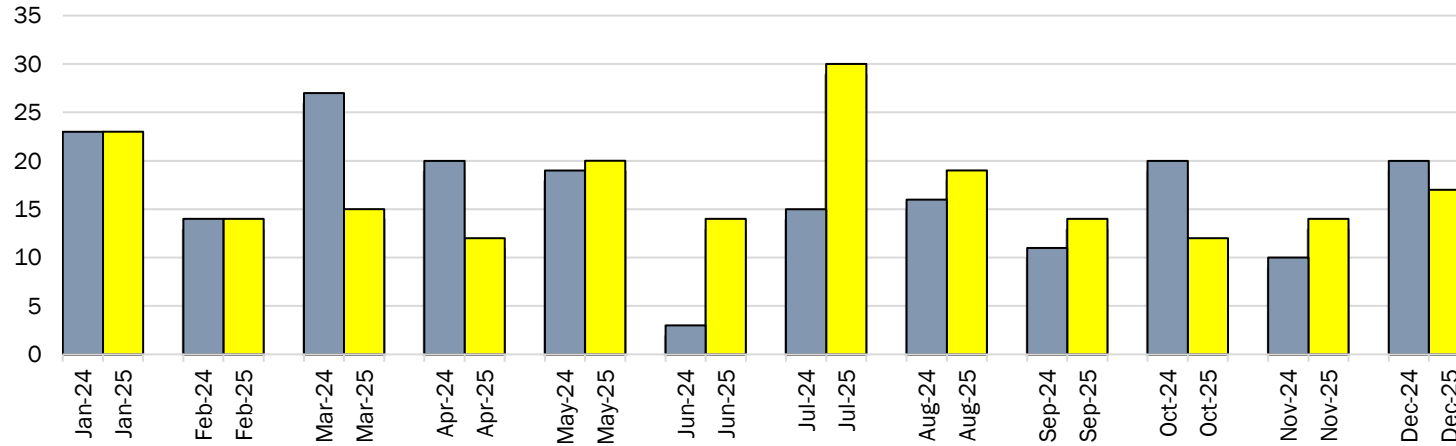

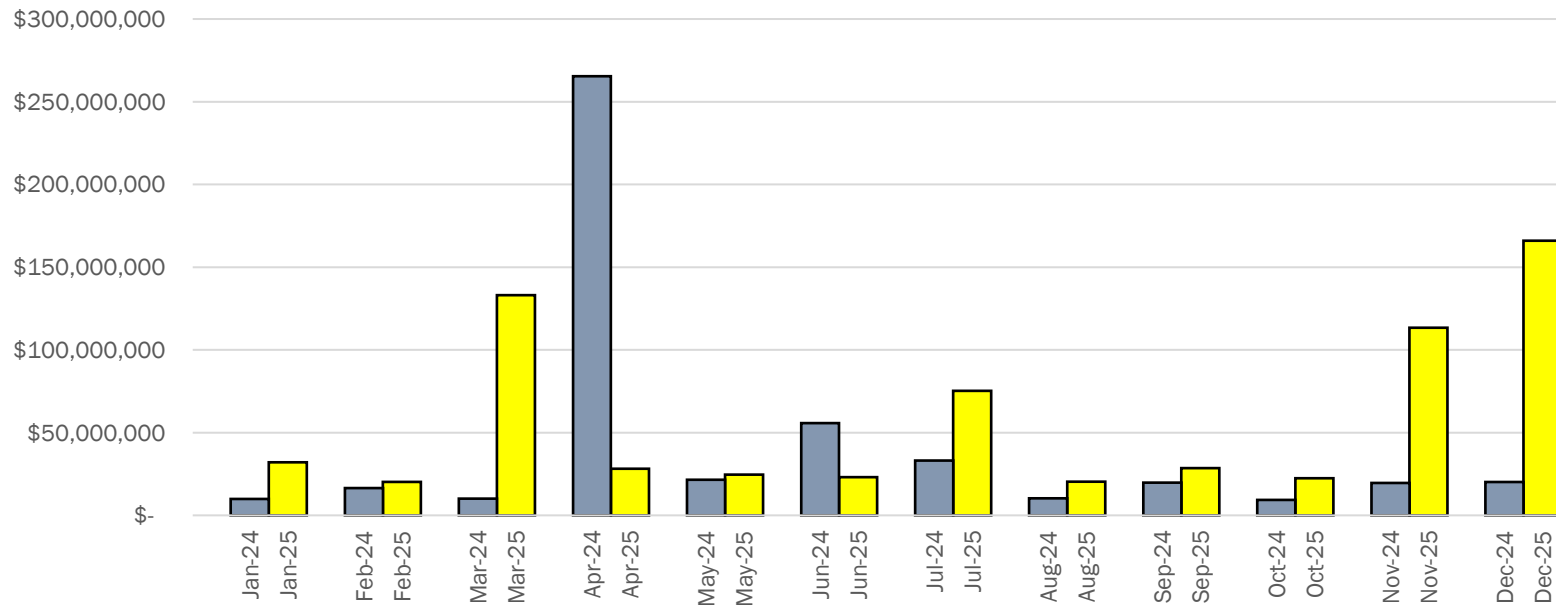
## Building Permit Applications Received Single Detached Residential December 2025



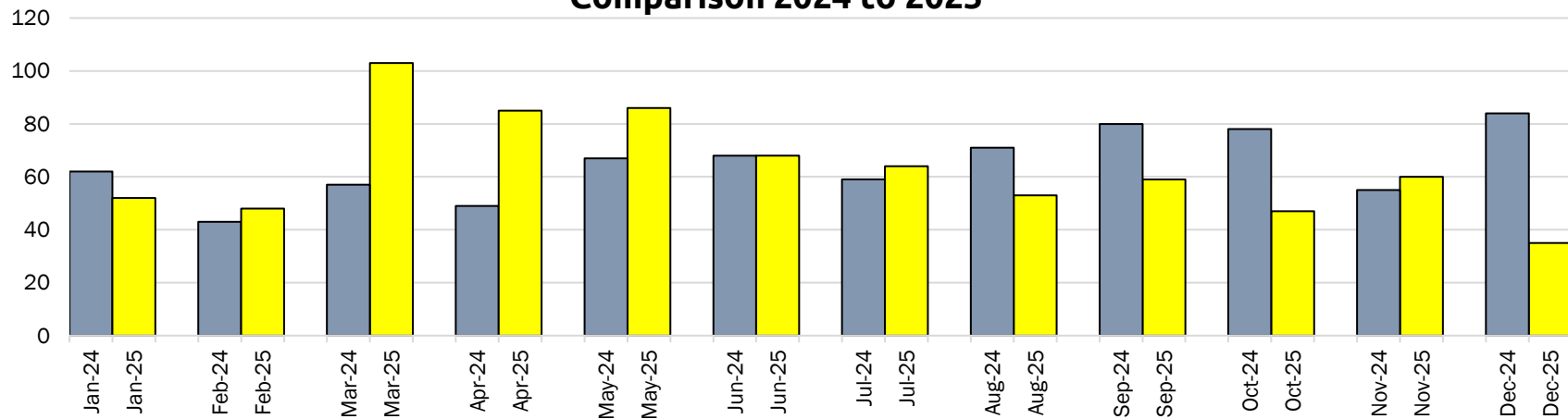
## Land Development Applications Received Comparison 2024 to 2025
