Insurance: In consideration and as a condition of the City of Delta (the "City") granting a film or other permit in relation to this Application, the Applicant will obtain and keep in force throughout the period of use permitted under any such permit such insurance policies: a commercial general liability insurance policy insuring and protecting the Applicant and naming the City as an additional insured (without any rights of cross-claim or subrogation against the City) against claims by any person for injury, death, property loss, or damage in an amount not less than \$5,000,000 per occurrence, with a provision that the policy may not be terminable or alterable without 30 days' prior written notice to the City, with an insurer and deductible and on terms satisfactory to the City; and as may be otherwise be required by the City. The Applicant will, prior to the issuance of any such permit and on demand thereafter, provide the City with a certificate of insurance giving evidence of such coverage to the City's satisfaction
