#### BACKGROUND:

Bylaw No. 8264 provides Delta with the authority to raise money from property taxes for 2023. Bylaw No. 8265 provides Delta with the authority to levy and collect property taxes for Metro Vancouver Regional District for 2023. Bylaw No. 8266 provides Delta with the authority to levy and collect property taxes for Tsawwassen Business Improvement Association for 2023. Minor housekeeping bylaw amendments were necessary due to changes to the Provincial Home Owner Grant Program (Bylaw 8041) and Delta's Pre-Authorized Withdrawal Program (Bylaw 8042).

- 1. This Bylaw may be cited for all purposes as "Delta Pre-Authorized Withdrawal Program Bylaw No. 6384, 2005 Amendment Bylaw No. 8042, 2023".
- 2. "Delta Pre-Authorized Withdrawal Program Bylaw No. 6384, 2005" as amended is hereby further amended as follows:
  - By removing the word "Municipal" in Section 2.
  - By adding Section 2.1 "Any person or corporation may apply to the Collector to pay utilities on a quarterly basis with an Auto-Debit option."
  - By adding Section 5 "The Terms and Conditions are set out in Schedule 2, Auto-Debit for Metered Utilities Program Terms and Conditions, attached hereto."
  - By replacing Schedule 1 with the Schedule 1 attached hereto.
  - By adding Schedule 2 attached hereto.

#### SCHEDULE 1

#### Pre-Authorized Withdrawal Program Terms and Conditions

- 1. Payments made using pre-authorized withdrawals will be processed on or about the 5<sup>th</sup> day of each month except as noted in Section 5.
- 2. The minimum monthly payment is \$20.
- 3. Instalments received will be first applied to any outstanding balances in accordance with the Community Charter Section 244.
- 4. The following terms apply to pre-authorized withdrawals for both Property Taxes and Flat Rate Utility Charges:
  - (a) Monthly pre-authorized payments will be withdrawn from the account holders' bank accounts on or about the 5<sup>th</sup> day of each month except for the month of <u>June</u>.
  - (b) The annual Flat Rate Utility Bill, mailed each year in February, will show the current year's utility charges less any prepayments. Property owners are responsible for paying the balance, if any, by the due date.
  - (c) The annual Property Tax Notice, mailed each year in May, will show current year's taxes less any prepayments and interest earned. Property owners are responsible for paying the balance, if any, by the due date.
  - (d) Monthly pre-authorized withdrawal amounts should be based on estimated Property Taxes less any eligible Home Owner Grant plus Flat Rate Utilities, and divided into 11 equal instalments. Account holders may choose to pay an amount different from the monthly amount calculated.
  - (e) Interest will be credited to the instalment account at the end of each month. Interest will be calculated, based on the month-end credit balance in the instalment account using the Royal Bank of Canada prime lending rate less 4%.
- 5. The following terms apply to pre-authorized withdrawals for Flat Rate Utility Charges ONLY:
  - (a) Monthly pre-authorized payments will be withdrawn from the account holders' bank accounts on or about the 5<sup>th</sup> day of each month except for the month of <u>March</u>.
  - (b) The annual Flat Rate Utility Bill, mailed each year in February, will show the current year's utility charges less any prepayments. The balance due, if any, will be withdrawn from the account holders' bank accounts on the due date.
  - (c) Monthly pre-authorized payments will be recalculated annually by the City of Delta.

#### SCHEDULE 1 CONTINUED

- 6. Participants in the pre-authorized withdrawal program must advise the Collector in writing, at least 14 days prior to a payment date, of any changes pertaining to <u>property ownership</u>, <u>bank</u> <u>account information</u>, <u>pre-authorized payment amounts</u>, or <u>termination of the program</u>.
- 7. A fee and applicable late payment penalties for returned payments not honoured by the financial institution will be charged to the instalment account, or the utility account for the Flat Rate Utility Charges ONLY program. The Collector may cancel the privilege of participating in the program if two or more payments fail to be honoured in one calendar year.

#### SCHEDULE 2

#### Auto-Debit for Metered Utilities Program Terms and Conditions

- 1. The metered utility payment will be the full amount noted on the property owners' Metered Utility Bills that are sent every three months. The balance due, if any, will be withdrawn from the account holders' bank accounts on the due date.
- 2. Participants in the auto-debit program must advise the Collector in writing, at least 14 days prior to a payment date, of any changes pertaining to <u>property ownership</u>, <u>bank account information</u>, or <u>termination of the program</u>.
- 3. A fee and applicable late payment penalties for payments not honoured by the financial institution will be charged to the utility account. The Collector may cancel the privilege of participating in the program if two or more payments fail to be honoured in one calendar year.
