Re: Urgent need to postpone Hwy 17A overpass repairs until Jan 2, 2024

The Delta Chamber of Commerce is **urgently requesting postponement of repairs to the Hwy 17A overpass**, part of the Highway 17A/Highway 99 interchange, **until January 2, 2024**. While the Delta Chamber recognizes the prioritization and expediency dedicated to this repair, the **scheduled timing will cause significant**, **negative impacts** on businesses in Ladner, Tilbury and the surrounding region.

Specifically, the timing of November 17th for a proposed eight weeks, will **hinder the following industries financially,** at a minimum:

- Food and Beverage through the cancellation or relocation of holiday gatherings and bookings
- Retail (Direct and Wholesale) both large and small scale, as detours redirect consumers to alternate retail destinations outside of Delta;
- Healthcare and Paramedical service providers: where individuals are utilizing their remaining 2023 extended benefits; and
- **Manufacturing and Distribution** through transportation delays and increased transit times, at year end delivery deadlines and while recovery from supply chain disruptions.

With **CEBA loan repayments due on January 18, 2024**, to qualify for the forgivable portion, it is **imperative that small businesses are equipped with every opportunity for success this calendar year**. The Food and Beverage industry has been one of the hardest hit during COVID and continues to be in a state of recovery. While the permanent overpass fix will benefit the majority in the long run, **delaying this repair by 46 days to save businesses is an acceptable compromise** for those impacted.

While I acknowledge that MOTI has undertaken consultation with the City of Delta, Delta's emergency responders, Delta Farmer's Institute, HUB, Translink and other Ministry projects in the area, you will note **the omission of the business community** in this consultation.

The Delta Chamber of Commerce requests that the repair of the Highway 17A overpass be delayed until January 2, 2024. This measure will also allow time to develop a coordinated communication strategy and prepare alternative Translink routes to service this area.

Thank you for your consideration. I look forward to receiving a reply from your office.
